Subject: Sudan Peace Process

Mr. President,

It is our honor to address this communiqué as Sudanese-American individuals working under the auspices of the Umma Group to advocate for mutually beneficial economic, political, and socio-cultural relations between the people of the United States and the people of the Republic of Sudan.

There is no doubt that the ongoing conflict in Sudan between the Sudanese Armed Forces (SAF) and the Rapid Support Forces (RSF) has created the world's worst humanitarian crisis and poses serious threats to regional and international peace and security.

We commend your decision—made upon the request of His Excellency, the Saudi Crown Prince Mohammed bin Salman—to accelerate the peace process and to impose sanctions on the Muslim Brotherhood in Sudan and worldwide.

In this context, we welcome the statement issued by the Foreign Ministers of the Quartet countries on September 12, which calls for:

- An immediate ceasefire through a three-month truce,
- The facilitation of humanitarian relief access, and thereafter
- The launch of a political process culminating in the establishment of a civilian government capable of achieving lasting peace and stability.

Sudan's internal war—shaped by ethnic tensions, extremist sectarianism, the vast scale of military operations, a recent history of harboring and supporting terrorist groups, and harmful regional interference —constitutes a dangerous and protracted conflict that threatens the stability and interests of neighboring and distant states alike.

A comprehensive peace plan must address the root causes of the conflict and all of its principal elements, as outlined in the Quartet declaration of September 12. The banning of the Muslim Brotherhood remains a critical and necessary step.

It is therefore essential to strengthen the conditions required to eliminate cross-border security threats posed by terrorist and extremist organizations, to prevent the spread of their influence, and to deny destabilizing regional and local actors—who benefit from the continuation of conflict—the freedom to operate.

It is imperative to drying up the sources of weapons coming into Sudan from all countries supporting both sides of the war at the regional and international levels, and contributing to the reconstruction of what the war destroyed and the damage inflicted on infrastructure, which has a direct impact on human life.

The future of governance in Sudan must be left to the Sudanese people to determine through an inclusive, transparent transition process free from the influence or control of any warring party, and under the supervision and auspices of the United States, the United Nations, the African Union, the Arab League, and IGAD.

Thank you for your swift and decisive actions aimed at ending this devastating armed conflict and the world's worst current humanitarian crisis.

Sudanese people everywhere will long remember the leadership and resolve of all who help bring peace to our suffering nation.
